WEEK IN REVIEW

Friday was the 12th day of the long (90 day) 2019 legislative session. Last week the Legislature conducted half-day sessions, concluding bill introduction, concluded floor debate on Rules, and then started floor debate on General File bills. All committees have started half-day sessions of hearings.

LB 139 (Kolterman) “Change provisions relating to a data base of contractors under the Contractor Registration Act” is set for hearing in the Banking, Commerce, and Insurance Committee on Monday, January 28th at 1:30pm. We will host a pre-hearing lunch for testifiers at our Lincoln office. We urge all LAC members to reach out to their Senators and to urge them to support and co-sponsor LB 139.

LB 26 (Kolterman) “Change provisions related to legal service insurance corporations” had its hearing earlier this week and advanced from General File today.
