### **WEEK IN REVIEW**

Today the Nebraska Legislature adjourned Sine Die at the end of Day 84. This concludes the 2019 legislative session six days earlier than the originally scheduled 90 days. The legislature passed 294 of the 731 bills introduced, which is approximately 40%. In comparison, this is a 14 percent increase from the last full session in 2017 which only saw approximately 26% of introduced bills passed. In addition to the \$9 billion biannual budget, this session marked extensive debate on property tax relief and tax policy.

The 2019 legislative session focused quite often on tax issues, especially property tax relief. Two major tax bills became law and two major tax bills stalled, one on Select File and its companion bills stalled on Final Reading.

During this year's "long session", IIAN's Legislative committee, co-chaired by **Bob Hoppe** of Columbus and **Ritch Nelson** of Fort Calhoun, actively watched 32 bills impacting insurance agents, consumers, or the industry.

**In a victory for IIAN members, insurance carriers, and hiring parties, [LB 139](#), IIAN's bill to address the problem of individual independent construction contractors who do not cover themselves for workers compensation, passed its "final reading" on March 15, and was signed by Governor Ricketts.** The new law will become effective around August 31, 2019. This represents a major accomplishment for the IIAN and is due to the hard work of our Legislative Committee, our Legislative Advisory Council, our IIAN staff and to the major help of Senator Mark Kolterman and Senator John Lowe. Thanks to all who helped make this hugely successful effort possible. [See final reading text.](#)

[Read more about LB 139](#) - IIAN will have additional information available this summer, after the Department of Labor finalizes the new construction contractor registration requirement. The DOL web site will contain new clarifying information that LB139 mandates regarding the insured status of individual independent contractors for purposes of Workers Compensation insurance.

#### **Other Bills Impacting Insurance**

IIAN supported [LB 116](#), which also passed on March 15; it authorizes electronic delivery of insurance policies and billing information to insureds - IIAN worked during the session to include an amendment protecting agents.

**IIAN also supported [LB 370](#)**, which would double Nebraska's minimum auto liability limits; the bill was heard on February 19 by the Banking, Commerce & Insurance Committee, which took no action to advance it. **IIAN opposed [LB 672](#)** regarding named driver insurance policies, which was also not advanced for floor debate.

**Just one Workers Compensation bill passed** – [LB 418](#) by Cavanaugh to change provisions under the Nebraska Workers' Compensation Act and change provisions relating to tort claims against the state, the State Self-Insured Liability Fund.
