Dues or contributions to the IIA of Nebraska/IIAB of America are NOT deductible as a charitable contribution for federal income tax purposes; however, dues payments are deductible by members as an ordinary and necessary business expense. A portion of the dues, however, is not deductible as an ordinary and necessary business expense to the extent that the Independent Insurance Agents of Nebraska engages in lobbying. The non-deductible portion of the dues for 2022 is 16%. According to IIAN Bylaws, dues are fully earned effective September 1.
