Dues or contributions to the IIA of Nebraska/IIAB of America are NOT deductible as a charitable contribution for federal income tax purposes; however, dues payments are deductible by members as an ordinary and necessary business expense. A portion of the dues, however, is not deductible as an ordinary and necessary business expense to the extent that the Independent Insurance Agents of Nebraska engages in lobbying. The nondeductible portion of the dues for 2023 is 18%. According to IIAN Bylaws, dues are fully earned effective September 1.
