



Inaugural Address by
J. Greg Zimmer – IIAN President 2017-18
Installed October 13, 2017, Embassy Suites, Lincoln, Nebraska

Thank you and good afternoon. I was looking out over the audience a few minutes ago, and marveling on how things have changed in the last 35 years...

A big change for me is being up here today. I never thought while watching my uncle John or my father Jim being a part of this organization, hey, "I want to do that someday" and now, thinking back, I wish I'd had. I wish I'd have been more involved and at an earlier age. I'm thinking both would have said something like "better late than never" ... it would be kind of cool if they were here today.

Elliot Bassett with the Young Agents Task Force is here, and I'd like to see that whatever this new board can do to encourage and support his group is done. It would be a shame to lose the input and energy of our young agents. I think we may need them to keep this train moving.

It's time to do something and we believe the New Talent Task Force is" that thing.
